## **ANGVA VISION**

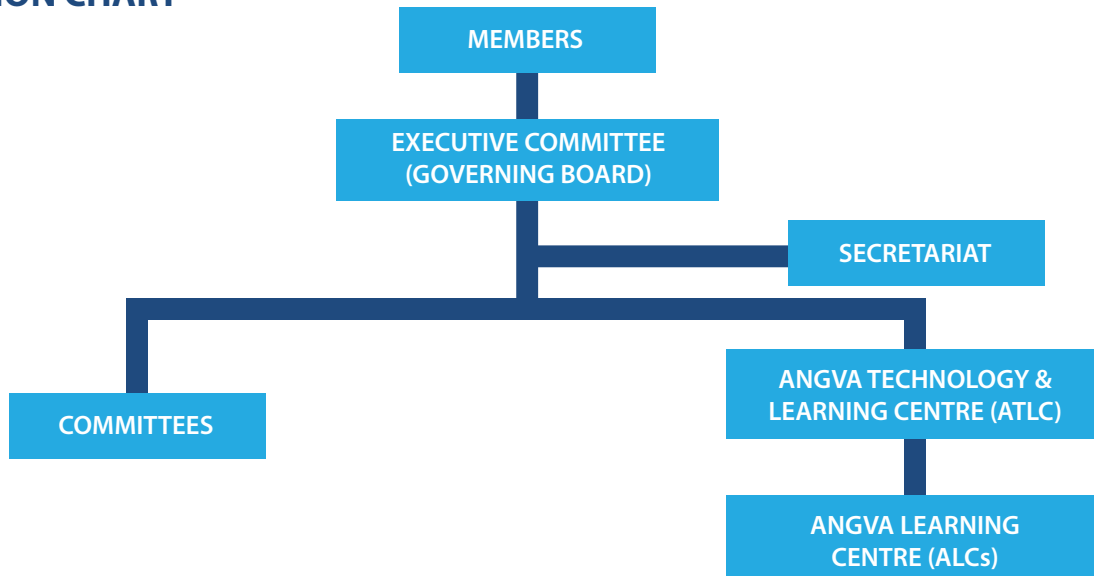
